Casino Terms & Conditions and Operating Guidelines (CTCOG) and Racing Entertainment Centre Terms & Conditions and Operating Guidelines (RECTCOG) Handbook Modernization

Summary of Key Amendments

The following key amendments reflect the main objectives of the CTCOG/RECTCOG Handbook modernization project:

1) Consolidation and realignment of handbook content:

 All CTCOG/RECTCOG policy was reviewed and where appropriate, policy was consolidated and realigned with similar policy types to improve the effectiveness and functionality of the handbooks for stakeholders.

For example, current section one in both the CTCOG and RECTCOG handbooks had become catch basins for any new policy over the years that did not warrant being a standalone section on its own. These policies have now been grouped into sections having similar policy types where they are more relevant, such as:

- o policy related to social responsibility issues (minors, banned entry etc.) were relocated to new Section 3 Responsible Service; and
- o GAIN program policies were relocated to Section 17 Licensed Charity.
- In some cases, policy sections/subsections were amalgamated with other policy where it was deemed it would be more relevant for clarity or the overall effectiveness of a policy.

For example:

- Section 9.3 Winner's Edge in both handbooks is a consolidation of three policy sections (e.g., CTCOG Sections 20.1, 20.2 and 20.3) in the previous handbooks that now presents the same policy in a more succinct and efficient format.
- Section 13 in the CTCOG and Section 9 in the RECTCOG Electronic Gaming is a consolidation of all
 policy in the previous version of the handbooks related to electronic gaming (e.g., slots and vlts) to
 improve accessibility of the policy and efficiency of the handbooks.
- Minor amendments have been made throughout the handbooks to streamline and provide clarity
 of certain policy or correct spelling/grammar errors with no impact to the intent of the affected
 policy.
- References to previously deleted sections/subsections and the subtle references to the last policy amendment dates have been removed to present the restructured CTCOG and RECTCOG as newly refreshed handbooks.



2) Modernizing handbook structure:

• The rationale for the new CTCOG and RECTCOG structure includes:

(Not all section numbers line up due to the nature of the differences of gaming operations. Efforts were focused on aligning content of the respective sections and every effort was made to align section numbers where it was possible.)
