## JOB SUMMARY

This position is responsible to conduct criminal investigations related to gaming revenues (i.e. cheat at play, theft, fraud and money laundering). Investigators also conduct investigations pursuant to the Gaming Liquor and Cannabis Act (GLCA) and the Gaming Liquor and Cannabis Regulation (GLCR). Conducts criminal and regulatory investigations involving gaming/liquor/cannabis licensees, Registered Gaming/Cannabis Workers and individuals employed in the gaming/liquor/cannabis industry. As a member of the Gaming Investigation Team you will participate in Criminal Code Part VII investigations into illegal gaming activities (i.e. common gaming houses, bookmaking, loan sharking, unlicensed lottery schemes and illegal internet gaming). Knowledge and compliance with the Peace Officer Act and Peace Officer Regulation is required. This position also assists in the administration and regulatory enforcement of the AGLC Anti-Money Laundering Program.

As a member of the Gaming Investigation Team you will maintain close working relationships with police and enforcement agencies to develop intelligence and engage in multi jurisdictional investigations. Knowledge and experience in obtaining and executing judicial authorizations is required.

Both superior verbal and written communication skills are essential. A thorough knowledge of the Criminal Code, the GLCA, the GLCR, and interpretation of legislation, case law, rules of evidence, criminal court proceedings, surveillance techniques, internet investigative techniques and the cultivation/management of confidential sources are required to be successful in this position. You will be working independently and in an operational team environment.

A valid Driver's Licence and dependable transportation is required for independent fieldwork as you will be subject to travel throughout the Province of Alberta, with some overnight travel required.

## SKILLS/QUALIFICATIONS

NOTE: An equivalent combination of education and experience may be considered. Candidates with lesser qualifications may be considered at a lower classification and salary. This recruitment may be used to fill future vacancies.

#### Regulatory Services Division

This Division is responsible for ensuring the integrity of the gaming and liquor industries in Alberta.

#### Investigations Branch:

- Protects the integrity of regulated gaming, liquor and recreational cannabis activities in the province;
- Investigates Criminal Code offences related to licensed gaming, liquor and recreational cannabis activities in the province, working closely with police services and other government agencies;
- Through an MOU with Alberta Treasury and Finance provides investigative and enforcement services relating to the Tobacco Tax Act. Also conducts criminal investigations relating to the Tobacco Tax Act, Fuel Tax Act and Tourism Levy Act;
- Through a partnership with the RCMP, CPS, EPS and other municipal police services, fully funds and manages the Gaming Investigation Team (GIT) established to prevent, detect and combat illegal gaming activities in the province; and
- Administers, regulates and enforces the AGLC Anti-Money Laundering Program.
