The Manager, Cannabis Quality Assurance is responsible for the continued execution of the quality management processes at AGLC, including but not limited to, audits, product inspection, regulatory compliance, driving product recalls, quality related complaints investigations, etc. This position will successfully guide AGLC in ensuring the quality and safety of the product received from the Licensed Producers meets Health Canada's and AGLC's standards to ensure the safety of Albertans.

This exciting position is responsible for, stakeholder relationships, policy, procedure and process development, planning and coordination.
