JOB SUMMARY

Reporting to the Manager, Gaming Eligibility and Programs, this position is responsible for assessing applications for charitable gaming licences (including casino, bingo, raffle and pull tickets). The position ensures that applicants meet eligibility criteria (researching and assessing bylaws, lease agreements, financial statements, contracts, records of program delivery, websites, etc.) in accordance with the Alberta Gaming, Liquor & Cannabis policies as well as conducting full eligibility reviews on currently licensed groups. In situations of non-compliance, the position will monitor and facilitate the donation of gaming proceeds as needed. The position will also attend Board Hearings as an eligibility expert witness.

Our successful candidate will have a high degree of personal integrity and the ability to be objective when reviewing applications. They will also have a comprehensive understanding of AGLC charitable gaming policies and all characteristics of the Alberta Charitable Gaming Model. The successful candidate will be comfortable making independent decisions, weighing and assessing criteria against legislation and policy. Excellent interpersonal skills are needed to be able to build relationships with stakeholders in conflict situations. Strong communication skills (written and verbal) are essential.
