#### Mandate

In accordance with the Gaming and Liquor Act, the Criminal Code (Canada) and within the policy framework established by the provincial government, the mandate of the Alberta Gaming and Liquor Commission (AGLC) is to:

- license, regulate and monitor gaming and liquor activities in Alberta;
- define operating policies and procedures for gaming and liquor activities;
- ensure integrity in the operation of gaming and liquor activities;
- collect gaming and liquor revenue;
- ensure business and program operations are run efficiently and effectively;
- disburse provincial lottery revenues;
- support industry and government initiatives to address problem gambling and responsible alcohol consumption; and
- · communicate to gaming and liquor stakeholders accurate and timely information.

The AGLC administers the Alberta Lottery Fund under the provisions of the Gaming and Liquor Act.

#### **OVERVIEW**

The purpose of charitable gaming in Alberta is to benefit charitable and religious groups. Under the province's charitable gaming model, eligible charitable or religious groups are licensed to conduct certain gaming activities, namely casinos, bingos, pull-tickets, and raffles.

The AGLC is committed to ensuring that the financial return to charitable and religious groups is maximized through these charitable gaming activities, and it does this by setting appropriate policies, procedures, and terms and conditions for their conduct. Maximizing financial returns in turn leads to greater benefits for the organizations, the programs and activities they deliver, and their communities.

Maintaining the integrity of gaming activities is also a prime focus of the AGLC. Through ongoing reviews of gaming activities, a diligent licensing process, and strict enforcement of policies, procedures, and terms and conditions, the AGLC works to ensure that groups licensed to conduct charitable gaming activities do so according to the requirements of their licence, with proceeds used to benefit Albertans.

On August 21, 2003, the MLA Review Committee on Charitable Gaming Licensing Eligibility and Use of Proceeds report was released. It contains 41 recommendations – accepted by government – intended to update the current charitable gaming policies and make them clearer to everyone involved in charitable gaming in Alberta. #### **ELIGIBILITY REQUIREMENTS**

A charitable or religious group is eligible for a licence to conduct gaming activities if the group:

- actively delivers a program or service which provides a benefit to a
  significant segment of the community. The program or service must be
  reasonably available to all members of the general public who qualify
  and wish to participate in that program or use that service; and
- uses revenue from its gaming activities for a charitable or religious objective or purpose.

With the completion of the MLA Review Committee on Charitable Gaming Licensing Eligibility and Use of Proceeds, two types of groups who were not eligible in the past are now eligible for gaming licences based on the charitable benefit they provide to the community.

#### These are:

- Non-profit child care groups, provided that they hold a government daycare licence and their program is open to all members of the community; and
- Adult sports groups with a youth component that meet the other associated requirements.

#### **ELIGIBLE GROUPS**

The types of groups who are eligible to obtain licences to conduct charitable gaming activities can be categorized as follows:

CATEGORY	DESCRIPTION
Agriculture	Organizations registered under the <i>Alberta Societies Act</i> or <i>Agricultural Societies Act</i> as an agricultural fair or exhibition board.
Arts	Performing visual and literary arts groups which focus on art galleries, dance, general and instrumental music, choral, opera, theatre, historical and multicultural organizations, and museums and archives. This also includes marching, school and youth bands, and related groups such as parent associations and booster clubs.
Community	Groups whose activities are of a general nature that support a variety of programs in the community (for example, community associations and community leagues).

Education Organizations including playschools, non-profit child

care groups that hold a government daycare licence, kindergarten, preschools, private schools, parent organizations in support of educational programs, and colleges, technical institutions and universities.

Medicine-Health Organizations assisting those afflicted with a specific

physical or mental disorder, organizations supporting basic medical research, and auxiliaries or support groups to health care facilities and people who are physically disabled.

Multiculturalism Organizations which identify themselves with a country of

specific ethnic origin and whose activities are of a general nature that support a wide variety of programs in the

community.

Recreation The organizations' activities are not of a competitive nature.

They may include support for recreational facilities and parks and recreation organizations, among others.

Religion Churches, parishes, temples, synagogues and auxiliary

groups which support the religious activity and focus on

furthering religious principles and objectives.

Senior Citizens Organizations where the majority of membership is 60 years

of age or older. Includes resident "clubs" in senior citizen homes and groups providing recreational and social

activities for senior citizens.

Service Fraternal, service and veteran organizations which are

established by a statute or international/national "charter."

Social Action Organizations which focus on specific issues of social

concern and promote these issues through social and

educational programs.

Sports Organizations which support competitive amateur

individual and team sports, including adult sports groups

with a demonstrated youth component.

Youth Organizations providing a variety of programming for

young people, including auxiliary groups in support

of these organizations.

#### **STRUCTURE**

To be eligible for licensing, the applicant groups must:

- have a broad based volunteer membership;
- have an executive democratically chosen from its volunteer base\*;
- not pay its members, directors or officers;
- have programs which benefit a large segment of the community, not the individual members' self interest;
- be a not-for-profit organization;
- have volunteers who are responsible for establishing, maintaining control of, and delivering the group's programs; and
- be incorporated (if a licence fee is required).
- \* An accepted recommendation from the MLA Review Committee on Charitable Gaming Licensing Eligibility and Use of Proceeds report allows for the appointment of up to 25 per cent of a charitable group's executive members by an external entity.

#### **USE OF PROCEEDS**

Returns from charitable gaming activities are intended to be used in a way that directly benefits communities. Gaming revenue may be used to pay prizes and expenses needed to operate an event. The remaining proceeds must then be used for previously approved charitable or religious purposes. Groups applying for a charitable gaming licence must specify on their application forms how they intend to use proceeds, and must submit financial reporting forms within a specified time frame after their event.

The following are some examples of ways that charitable gaming activities benefit the community at large:

CATEGORY	BENEFITS TO THE COMMUNITY
Relief of the aged or disadvantaged	relief to the poor; programs for the elderly to remain active in society; social services and educational programs for the emotionally/physically distressed
Advancing education and learning	student scholarships; aid to schools; aid to libraries; aid to museums; aid to the arts; aid to the preservation of cultural heritage
Help to the community	improvements to quality of health; support medical research; aid medical treatment programs; supply a facility for community use; support competitive amateur athletics; contribute places for worship and other religious programs

Each of the above categories for use of proceeds must involve the delivery of a program to the community. Delivering this program will cause groups to incur different expenses. The following are examples of eligible uses of gaming proceeds:

- Purchase or rental of equipment, furnishings and supplies to deliver programs
- Providing equipment, supplies, or programs to educate students
- Providing relief for people in distress, or victims of a physical disaster
- Travel to deliver a group's services in Alberta

As part of the MLA Review Committee on Charitable Gaming Licensing Eligibility and Use of Proceeds, the use of proceeds policies have been clarified to ensure gaming proceeds are used to directly benefit the community.
