Licensing Conditions


AGLC may refuse to issue a Bingo Facility licence if it is satisfied that a member of the executive has, within the five years prior to the submission of the application:

- (i) committed an offence under the *Criminal Code (Canada)*, the *Excise Act (Canada)*, or the *Controlled Drugs and Substances Act (Canada)*;
- (ii) committed an offence under a *foreign Act* or Regulation that, in AGLC's opinion, is substantially similar to an offence referred to in subclause (I);
- (iii) contravened the Alberta *Gaming, Liquor and Cannabis Act* or Regulation, or the predecessor to the Act or Regulation;
- (iv) contravened a condition imposed on a licence or registration issued or made under the Alberta *Gaming, Liquor and Cannabis Act* or a predecessor of the Act;
- (v) has within the five years prior to the submission of the application, been serving a term of imprisonment of three years or more.

Notice to Applicants

Licensing is subject to all information provided on this Application being truthful and complete.

AGLC will review licensing requirements if an individual fails to comply with the above; or is charged with, or convicted of, a criminal offence. This review could lead to the licence being suspended or revoked.
